Seeding For The Future

any of us know the story of Johnny Appleseed. Fewer of us know that he was a real person. For forty-nine years, John Chapman ("Johnny Appleseed") roamed the American wilderness, devotedly planting apple trees. He created apple orchards in the wilderness spanning an estimated area of 100,000 square miles. Some of these trees are still bearing fruit after 150 years.

The longevity of trees and their ability to spread makes John Chapman's contribution one of the most lasting in American history. Laws, wars and political parties have come and gone; lawyers, soldiers and statesmen have grown powerful, only to see their life's work eventually undone. But John's apple trees have endured and multiplied, changing the face and food of a continent.

So what does this have to do with model railroading? I think there is a parallel about making a lasting contribution and I think there is a parallel about how it is done.

Recently (again!) I was given a large collection of Railroad Model Craftsman magazines from someone who got them at a library surplus sale, keeping only the few issues of interest to him. I believe he saved the magazines from becoming recycled paper.

Unfortunately, hobby magazines we donate to libraries sometime go right out the backdoor to used magazine sellers or, worse, to recycling. The reasons are the libraries don't always have space to keep specialized magazines and newer issues of MR, RMC and other larger circulation hobby magazines have little market value. (Believe me, I've tried to sell my own back issues for peanuts at railroad swap meets, usually without success.)

So what should we do with magazines we no longer need? Why not take the Johnny Appleseed approach? Seed the land with them for a new generation of model railroaders. Spread them around to promote interest in the hobby. Leave a copy or two in the reception area of your doctor's office when you visit. Leave them in your break room at work. Leave them at the airport when you travel.

Some certainly will be tossed, but a number of them will go home with someone to spark their interest, or their child's interest, in model railroading.

Take the Johnny Appleseed approach. Help make a lasting contribution to the hobby. 표했

he Board of Trustees Meeting held in St Louis, MO opened on the 6th of July and was a very spirited and busy meeting. Here is the main part of the meeting.

1. Most of you have heard by now that as of the 29th of June,2001 Miss Connie Rudder (Executive Director) is no longer with the NMRA. She elected to resign effective June 30th,2001. Until a new executive director has been named, Administrative Manager Debbie Bennet and Library Director Gordan Belt will report to Executive Vice President John Roberts, while department heads will report to President Allen Pollack. This will allow the association to function as smoothly as possible during this period. All of us in the NMRA family wish Connie well and thank her for her eight years of dedication to the NMRA.

2. Past President Bob Charles was relieved of his responsibilites as Development Department Director-no replacement as yet.

3. Brian Kampschroer is no longer Meetings and Trade Show Director- Henry Jordan replaces Brian.

4. Tom Draper replaces Henry Jordan as Trade Show General Manager.

5. New Nominations Chairman is Mike Brestal (Mid Central Trustee).

6. George Schmid (a CPA) is now the new Treasurer replacing Doug Auburg.

7. Long Range Planning Committee Chairman C.Getz reviewed the LRP Plans for the upcoming mid year meeting. A draft will be submitted at that time, with final approval to be sent to the membership for voting in the near future.

8. Philadelphia was successful in it's bid for the NMRA 2006 Convention.

9. Nominations are in place for the next President and Executive Vice President elections. For President Allen Pollock ,and for Executive Vice President, John Roberts and Dean Windsor.

10. There was a new Department created recently called the Education Department under the direction of Rich Coleman. The NMRA is a non profit association whose purpose is to promote and teach the art and craft of model railroading. The NMRA Education Department structural umbrella also encompasses the Modeling with the Masters Program and the coordination of the Speakers Bureau. Each Division Director needs to appoint a Division Education Chair . We have a Pacific Southwest Region Education Chair in Jan Wescott. For additional information please contact Jan or see her column on Page 9 in this issue of the *PSR Dispatch*.

Now For The Most Important Issue: DUES.

11. Trustee Actions in St Louis Your association has been spending more dollars than it has been receiving! This harsh reality faced the NMRA Board of Trustees at its meeting last week in St Louis. There appear to be two major factors causing the problem.

a. First the NMRA has expanded and improved many member services in recent years. Costs that looked reasonable at the time these services were voted in have escalated. An example of this is the NMRA Bulletin.Paper markets, pre-press costs and magazine printers all work in a volatile marketplace price wise, and organizations they serve must meet unpredictable production cost increases. Postage just went up (a two cent per piece increase) with other raises announced, especially in magazine delivery! This includes the NMRA Bulletin and bulk mailings. Each increase adds an estimated \$25,000 to our annual expenses or over a \$1.00 per member. We did not budget adequately for these unexpected cost increases which are out of our direct control.

b. Second, in recent years the Board of Trustees was presented with and has voted balanced operating budgets in good faith. Now a budget calls for two major things, projected income and expenses for the next fiscal year. The Board of Trustees examined both factors and deemed they were achievable with certain pledges of project profits and fundraising made by volunteers and the administrative team.

The Administration has controlled the expense side of the Budget generally living with in the budgeted figures. However, the projected income frequently did not materialize as promised. Several major instances, income promises turned out to be BLUE SKY. Thus RED INK. The NMRA is not broke, we have assets but the BOT had to act to protect them from further erosion. At the February mid-year meeting, the BOT received the BRUTAL FACTS with an administration request for \$14.00 annual dues increase. A motion was passed to authorized an increase up to \$48.00 was passed with the final vote to be taken at St Louis. The BOT conducted an open e-mail discussion from March to June asking for facts, alternatives and reappraised the expense side of the new fiscal 2001-2 budget. The President with BOT approval, placed a cost containment freeze on all expenses not necessary for the day to day operation of the association. The Library archival system has been investigated and revisions are being implemented on advise of engineers to save utility costs. Two vacant positions have been left unfilled.

At the St Louis BOT Meeting, the Trustees adopted measures to focus on the Association's main core purposes. Each service was carefully examined. Does this contribute to the core purpose and require dues income ? Can it become a stand alone without budget dependence? Can this service contribute to the income of the association? Has this service outlived its original intent ? Further the BOT put severe restrictions on the BLUE SKY Projections. Also reaffirmed the total separation of the HOWELL DAY Museum from any dues support.

After all these actions were taken , the BOT found it necessary to increase the dues from \$34.00 to \$45.00 per year. Loss of membership may be experienced and has been factored into the size of the increase. At \$45.00 dues, the NMRA is still well below the dues of other major organizations. This will become effective September 2nd,2001.



Four PSR members participated in the model construction contest during the NMRA national convention at St. Louis. Every PSR participant won at least one award.

Allen Gross, MMR, won his third Gold Award (Best of Show) in these national competitions for a magnificently detailed and finished Clyde Iron Works



double ended, four line, self propelled logging skidder. Allen's model also won the *TIMBER TIMES* 1st Place Logging Model Award and the TESTORS-FLOQUIL Best Finish-Non Revenue Award.

Karl Winkler won 1st Place in the Steam Category with a beautifully crafted O scale C&O 4-8-4 class J3A locomotive. Karl's model also won the **Bachmann Innovation**, **BLE Brass Bell** (Karl's second), **Senior Modeler** (over 65) and the **Wm. J. Lenior Locomotive Construction** (for scratchbuilt Steam Loco) awards.

Duane Buck won 1st Place in the Diesel and Other category with a superdetailed GN F7A/B/A passenger set. Duane's GN FTA/B passenger set also took 2nd place in this category.

Model Railroading is World Wide, Education is Universal !

id you know... that the NMRA is a non profit "educational" association whose primary purpose is to promote and teach the art and the craft of model railroading?

To further this goal, the Board of Trustees established a new Education Department, last summer, and appointed Rich Coleman as the NMRA Education Director. Allen Pollock, NMRA President, announced the appointment in his column in the February 2001 issue of the *NMRA Bulletin*. Rich is ideal for this position after his many years in the Achievement Program and everyone was pleased he accepted the appointment.

In order to achieve the Education Department's primary mission, each Region will appoint a Regional Education Chair. And here I am... it's called "railroading" by Bob Sherlock.

In any event, I've accepted the challenge for the PSR. Personally, it is an area that interests me and I am excited at the opportunities presented by the creation of this new department.

The very first hurdle is to have each Division Director appoint a Division Education Chair. I have drafted a position overview to serve as a guideline and will be forwarding this to all Directors at the end of September. It is my hope that all Division appointments can be accomplished by the end of November. I will publicize the announcements in the following *PSR Dispatch*. This schedule will allow the PSR to be ready by the first of the year.

The essential responsibilities of the Division Education Chair are structured to be of a reporting nature and as a point of contact. This, in itself, will not be very time consuming; however, the position also affords opportunity to encourage and promote other educational activities as options.

It is my goal to extract from the Division reports various highlights of educational activity and publicize them in this column. This will serve two purposes: 1. Recognition of PSR educational activities and 2. Generate growth for new ideas. The shared information will expand our source for ideas and may prevent complacency.

The documented Division reports will be combined into one PSR report and channeled to Rich Coleman. National officers will then have at their disposal comprehensive documentation to justify the Association's status as a non-profit organization, should the need arise.

Change can be good and I definitely feel the focus is on the right track here. After all, what is education in our hobby? Is it sharing modeling tips in a clinic? Helping budding model railroaders? Getting involved with the Boy Scout Merit badge program? Interacting with Junior College programs? Sponsoring youth clinics? Promoting the PSR/NMRA? You bet it is and we do it all the time, except there isn't any documented proof. We're going to change that!

We learn through education and it is through education that we have become the most popular hobby worldwide.


From email via Gary Stilts and David Coscia:

Lynn Austin's modular railroad will be on display at the Las Vegas Limited Train Show.



I know that during my learning curve, I will make mistakes, so kindly let me know about them and they will be fixed.






Inviting You to Stop By John J. King

ello everyone, I just wanted to tell you a little bit about my South Pacific Coast Modules and invite you to stop by when at the Train Show at the Palace Station for the PSR Convention. I've been displaying modules on my own since 1996 at the Nationals in Long Beach. In 1998 I displayed my modules at the PSR convention in San Diego where I won an award and most recently I took my display to Torrance and received an award there. In addition, several structures on the layout have received ribbons at both Torrance and in San Diego.

It is my hope to bring up 14 modules to create a 12x24 layout in Las Vegas. The modular layout is supposed to be "non specific" and "generic" to provide opportunity to experiment with different types of landscape and scenery. It was to be a beautiful stage for a steam Cab Forward, Mogul, a string of F-7's, etc. Somehow this seems to be changing. I am an SP fan and the layout is beginning to resemble Beaumont Hill more and more although that part still needs tweaking.

F-7's and GP-9's while being retired are still the dominant locomotives throughout the SP system. Their replacements are evident everywhere and passenger service is becoming rare (but no Amtrak just yet). The Sunset, Argonaut, Golden State and Imperial Valley Flyer still polished the rails over the "Hill". As did the name freights like the Blue Streak, Valley Hauler, Merchandiser East and West and of course, the ore trains.



SP built these special cars to haul "Ferrite" that could carry 100 tons. "Ferrite" is the name of the enriched Eagle Mountain Ore. Did you know SP helped Kaiser Steel dig the biggest hole in the Western United States? Well, now UP wants to help fill up the gapping chasm at Eagle Mountain with LA County trash. That's not a bad thing?!

So there it is...time era of October 1969! Come by and see how well I did and I thank you letting me visit with you.
