

THE PSR BACKSHOP Pat Raymer

Greetings PSR Members!

This is my inaugural article as President of the PSR. I would like to thank everyone who took the time to vote in the regional election. Even with the usual one horse race, there was an excellent turn-out. Credit goes to elections chair Vic Cavalli for managing the election.

I am looking forward to continuing to serve the region for the next 2 years. These are dynamic times, and the region faces many challenges. I am sure that, with the able assistance of the regional board of directors, we will rise to meet these challenges.

The PSR board of directors meeting, which would have normally been held at the PSR convention, took place via Zoom on October $25^{\text{th}} - 26^{\text{th}} 2020$. The meeting was divided into 2 two hour meetings. It was at this meeting that the results of the election were certified and the official transition of the offices of President and Vice-president took place.

Items on the agenda included the formation of a separate region by the Arizona division, and the ongoing progress of the PSR 501c3 non-profit corporation filing.

The Arizona Division has expressed interest in forming a separate region, and has been preparing a petition to that end. The primary reason for this has been stated as an aging membership and waning interest in travel to Southern California for conventions and other events. There was no opposition voiced by the President, Vice-president, or the other Division Directors. The National administration is aware of this, and has reached out to me for comment. The matter will likely be on the agenda for the mid-year National Board of Directors meeting in February 2021. If the Arizona Division is successful in their effort, the remaining three divisions in the PSR would be faced with changing some of our traditional procedures. The one that stands out immediately is the change from a 4 year convention cycle to a 3 year convention cycle.

The opinion has been expressed that this would put undue pressure on each Division to produce a convention with such a short turn-around time. One possible solution would be to divide the annual convention workload across all of the Divisions with coordination by Region leaders. The first opportunity for this would be the 2022 convention, as the 2021 convention is pretty well locked in. Stay tuned for more on this in the upcoming months.

The 501(c)(3)incorporation filing continues, with the application submission occurring within the next couple of weeks. We will likely have this finalized early next year. Because of our incorporation plans, the PSR bylaws and Manual of Operations required revision. I distributed the draft version of the bylaws to the voting members of the Board and the Treasurer and Secretary for comment. The final version of the bylaws will be made available to the PSR membership for review and approval early next year. Vice President Gary Butts has agreed to review the Manual of Operations and recommend revisions to align it with the new bylaws.

Other items discussed at the meeting included membership attraction/retention strategies, the NMRA atrisk persons protection policy, and the stagnant "life member account". The "life member account" is a hold -over from the days when there were administrative costs involved in communications between life members and the region (printing, postage, etc.). The board unanimously voted to remove the restriction on this account and transfer it to the general fund.

2020 has been one heck of a year and I won't miss it when it's gone! It is said that when a door closes a window opens. A lot of doors closed in 2020 and so we found some open windows. As an organization we must find ways to give value to our members, and through creative thinking we are finding our way. I have high hopes for the coming year and am looking forward to better times ahead.


To that end, we are still actively pursuing incorporation of our Region as a non-profit entity. This effort has been delayed but is continuing and I'm sure will be detailed in other columns in this publication.

On the new news front, the Region as procured a stock of HO and N scale car kits specifically earmarked for use in securing new members at public train shows, swap meets, etc. The idea is that any first-time new member to the NMRA that turns in a completed Regular membership application (not for Rail Pass or rerail) along with the required dues at one of these events receives one of these model car kits as an incentive. See your Division Director to secure these cars for your local Division public events. Also, on the horizon, is a review of our Region's Manual of Operations and possibly incorporation of some changes to our By-Laws as well. These documents basically outline how we, as a Region, conduct our day to day business. You can review these documents by download from our Region Website under the "Library" header. Incorporation as a non-profit requires a few changes to these documents to clarify how we proceed. The changes are relatively small since we have been conducting ourselves in a non-profit manor since inception, but specific details need to be delineated to satisfy the IRS. I have signed-up to recommend changes to the MOO and hope to have them ready for review at our next Directors meeting.

Also, relatively new is the change to Region-wide upgrade of the Golden Spike Awards in the PSR Achievement Program. Taking a que from our Cajon Division, all new Golden Spike recipients within our PSR Region now receive, in addition to a nice certificate, a mounted Golden Spike trophy with individualized plaque and a Golden Spike trophy with individualized plaque and a Golden Spike lapel pin to add to your NMRA shirt or hat. Your Division AP chairman now has a stock of these awards so finish up those Golden Spike requirements, have them certified by your Division AP evaluation team and display your award and pins! Cool stuff!

The Cajon Division was able to hold an in-person Covid compliant meet in Orange County last month and it came off without a hitch. It was really nice to see old friends (outside and in masks, of course), new models and catch up. They are planning to try again, virus permitting, early next year.

Stay Safe and I hope to see you soon. – Don't forget to register for our 2021 Convention in September.

Pre-convention clinics, layout tours and Welcome Reception. General PSR Membership meeting including continental breakfast, over 34 first class clinics to attend. Check them out on the web site, and lots local layouts to visit and Op's layout for operators. There is also a show room for you to show off all the items you have built over the last year and this year there will be a one-foot challenge with cash prizes. Also included is the Hobo Auction with numerous quality and classic items up for grabs. And let's not forget the Swap meet and Annual PSR Awards and Recognition Banquet. Brining a spouse, we have a great Non-Rail program planned that includes clinics, social events, and tours.

I am happy to report that more applications for AP Certificates are coming in and that is a good thing. It appears that many modelers spent the time during the stay at home orders to work on their model railroads and to go back over old paperwork to see if they have completed any of the certificate categories like Volunteer or Official and Author. And others have been improving their layouts, working on cars, structures, or motive power, and now that some of the requirements have eased up and with social distancing their work is being evaluated. This is encouraging and I would encourage members to contact their Division AP Managers to see how they can get their work evaluated.

This past month Bob Ginger from Arizona received his AP Certificates for Author, Scenery, Structures and Electrical Engineer and currently has his Dispatcher paperwork in for approval. And Frank Baker from Arizona has also received his Certificate for Official.

There are currently 2 modelers in Cajon who will have their layouts evaluated in the next week for Civil and Electrical. And at the Cajon Division meet last month, 7 merit awards where issued for structures to three modelers so we can expect to see some certificates being issued soon.

So, going forward look at the lack of train shows and club meetings as an opportunity to make improvements to your layouts, build cars and structures so as the restrictions ease up you will be ready to get your work evaluated. If you have any questions, contact your Division AP manager they are there to help you.

PACIFIC SOUTHWEST REGION 37 TREASURERS FOURTH QUARTER DISPATCH REPORT SUMMARY:

During the period June 30, 2020 through September 30, 2020 there were very limited expenditures by the Region.

The September 30, 2020 Bank Statement indicates that the Region has \$35,435.27 in the Region Checking Account.

There were only a couple of transactions during this period:

- Deposit of \$905.00 Membership Rebate (Not distributed to Divisions, held to pay for Region incorporation costs, per Board action).
- Reimbursement of \$89.00 for Election Buddy costs for Region Election

One transaction that occurred since October 1, 2020 and not reflected in the September 30, 2020 account balance, was a check in the amount of \$2,804.00 made out to the Los Angeles Division to cover one-half of the 2020 LA Junction Convention losses (By action of the Region BOD)

Historian's Report

This Historian's report reflects what so many others have noticed about 2020:

(Almost) nothing happened!

I say "almost" because one important thing was discussed in the last PSR Board of Directors meeting; the expanded responsbilities of the Historian. From having been limited to take care of, and add to, the collection of Convention cars, it now includes collection and preservation of information pertaining to past Presidents and Directors, Member-of-the-Year recipients, and a unified display of AP Awards winners. Add to that to maintain the *Dispatch* newsletter collection. A great deal of progress has been made here and now comes the hunt for missing issues.

That's a mighty big task to get started on and I will have to call for everybody's help in achieving these lofty goals. I will work with the PSR Webmaster to create a corner on the PSR website for these items. Once that is up and running I will get back with more details requests for missing data.

The convention memorabilia collection includes every issued car from 1982 through 2020 with 1982 being lettered for PCR and 1983 PCR/PSR. No cars were issued in 1997 and 2015.

Patches are missing for following years: 1982, 1983, 1985, 1986, 1988, 1989, and 1998. No patch was issued in 2020.

Frank Baker, our Arizona Division Director, graciously donated the patch from the 1992 convention.

Pins are missing for following years: 1982, 1983, 1985, 1996, 1998, 2000, 2001, 2003, 2004.

I am looking for confirmation that patches and pins were, or were not, issued for these years. If anyone knows of a missing patch or pin and is willing to donate them to the collection, please contact me via email: <u>his-</u> tory@psrnmra.org

I will gladly accept a scan, or copy, of the patch or pin, I consider that better than having an empty spot in the collection cabinet.!

History of the NMRA's Pacific Southwest Region by Don Fowler, MMR

The Pacific Southwest Region (PSR) officially began on June 1, 1982. Originally part of the Pacific Coast Region (PCR), our Region consists of four Divisions; Arizona, Cajon, Los Angeles, and San Diego covering the entire state of Arizona and the southern portions of California and Nevada.

The proposal to split the Pacific Coast Region was first presented at the PCR Board of Director's Meeting at Reno, NV in October, 1980. The primary argument in favor of the proposed separation was due to the geographical and member size of the PCR and the related difficulty in serving the large number of members at the region conventions. Los Angeles Division Director Robert A. Rowe recommended that the new region be known as the Pacific Southwest Region.

In January 1982, the membership of the PCR voted in favor of splitting their Region as recommended. Official approval from NMRA National was granted at the February 1982 mid-year board meeting of the Board of Trustees.

On May 1, 1982 an unofficial first meeting of the PSR Directors and other interested Region members was held to propose a slate of officer candidates for the first election, held in June, 1982. Robert A. Rowe was elected as the new Region's first President. The first official meeting of the PSR Officers and Directors was held on October 2, 1982 in Needles, CA. The first issue of the not yet named newsletter was published in October, 1982. In December, 1982 the name "PSR Dispatch" was approved with a logo designed by Bruce Briggs.

The first annual PSR Convention was held May 17-20, 1984 in Scottsdale, AZ with the title "Saguaro '84" and adjourned with the Region's first Annual Membership Meeting on May 20, 1984.
